Sub: Rejection of Application for Reclassification of Promoter/Promoter Group to Public Category under Regulation 31A of SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015

Dear Sir / Madam,

We refer to your application dated February 10, 2025, seeking Reclassification of Promoters and Promoter group under the provisions of Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

In this regard, your attention is drawn towards the Regulation 31A (3)(b)(ii)(iv) of SEBI (LODR) Regulations, 2015 which provides that this sub-clause shall not apply in cases:

- a) Where the promoter(s) seeking reclassification, and any persons related to them, do not exercise control over the listed entity, either directly or indirectly.
- b) Where the promoter(s) seeking reclassification, and related individuals, are not represented on the board of directors of the listed entity. This includes not having a nominee director.

Exchange observed that Mr. Rohitkumar Rameshkumar More, who is son of the promoter, currently holds a position on the board of directors. This constitutes a direct relationship between the promoter and a board member. Such relation is deemed to indicate continued indirect control over the company's affair, violating the aforementioned provisions. Hence, the listed entity's application for reclassification of promoters group is rejected.
